

Educational Officers under orders of transfer will hand over charge to their Senior Asst./Senior Superintendents of their respective schools/offices and will assume charge of the new posts. The Deputy Directors will make necessary charge arrangement in respect of Headmasters/Asst. Educational Officers wherever substitutes are not posted. In sub Districts where there are two Asst. Educational Officers the senior among them will hold the post of Principal Asst. Educational Officer and the junior among them will hold the charge of Additional Asst. Educational Officer. In the schools where there are two Headmasters the senior among them will hold the post of Principal Headmaster and the junior will hold the charge of Additional Headmaster. Orders for the posting of substitutes to the resultant vacancies will be issued separately. RTC should be forwarded to all concerned as usual.
